Tom's tech tips



Use the LDD Online Utility often

With Internet Explorer as your browser, you can use our website, spellchecker, print documents, and even access Teraview® from our products. Unfortunately, IE can be affected by updates and other things, but our LDD Online Utility will fix them. Use the utility if you have one or more of these types of problems:

- Accessing our products websites for the first time when it should prompt you to run the Utility
- Merging, viewing or printing files or documents, or when you notice information is missing in files and documents
- Accessing a product, especially after you have updated your software, or if you get errors, such as MSXML4.dll errors, script errors or Windows pasting errors

To run our LDD Online Utility, from the bottom right corner of a product website, such as from RealtiWeb® - Ontario, click this icon: .

A File Download - Security Warning dialog appears. Ensure you close all IE browsers and other web-based services, and then on the Security Warning dialog, click **Run**. If you need help or you are still having problems, call our support Hotline at 800-363-0600 (416-367-0600).

Create Wills on the web

LDD's WillPowerWeb® program is a comprehensive, web-based wills production system. With WillPowerWeb, you can create Wills, Powers of Attorney and other related documents using our predefined LDD templates and clauses, or you can create your own. You simply enter data once into our easy-to-use screens, and then you can create all the documents you require.

Pricing is transaction-based, so you only pay when you use the system. There are no license fees or support costs. Sign up is quick and easy. If you are not a LawyerDoneDeal Web Services subscriber you must agree to the LDD Web Services Subscription Agreement and complete and fax in the LDD Web Services Registration Form. If you are an LDD Web System subscriber, call us at 800 363-2253 (416 367-0600), and WillPowerWeb will be added to your services.
